

## NOTICE OF GRANTING LETTERS PATENT.

**PUBLIC** Notice is hereby given, that under Chapter Eighty-five of the Consolidated Statutes of New Brunswick, 1903, and amending Acts, Letters Patent have been issued under the Great Seal of the said Province, bearing date the Seventh day of July, A. D. 1909, incorporating Frederick E. Law, Merchant; Robert Clarke, Hotel Keeper; Walter R. Stewart, Commercial Traveller; Amon A. Wilson, Barrister-at-Law; and John Hamilton, Plumber; all of the City of Saint John, in the City and County of Saint John, and Province of New Brunswick, for the following purposes, namely:—

To purchase, acquire and take over, continue and carry on the retail, stove, tinware and plumbing business at present carried on by Frederick E. Law, at No. 221, Union Street, in the City of Saint John in the Province of New Brunswick, and the connections, stock, assets, leases, personal property, rights and credits of said Frederick E. To manufacture, buy, sell and otherwise dispose of and deal in by wholesale and retail all kinds of metal and wood goods and supplies, and to manufacture, import, buy, sell and otherwise dispose of and deal in all goods and materials and supplies usually associated or connected with the stove, tinware, plumbing and heating business, or the manufacture aforesaid, and to act as commission merchant, broker, agent or in any other capacity for hire for any person or persons, firms or corporations carrying on business with like objects.

To purchase and acquire such real and personal property as may from time to time be deemed necessary for all or any of the purposes of or incident to the business aforesaid or any part of the same with power from time to time to encumber the same or any part thereof, and from time to time to dispose of any property, both real and personal, at pleasure.

To do all such other things as are incidental or conducive to the attainments of the objects for which incorporation is sought as aforesaid.

The company hereby incorporated shall be liable for the debts and obligations of the said Frederick E. Law, existing at the time of taking over said property, and may be sued for the same in any court of competent jurisdiction, by the name of "The People's Stove and Plumbing Company, Limited," with a total Capital Stock of Twenty thousand dollars divided into Four hundred shares of Fifty dollars each, and with its head office at the City of Saint John.
