PHYSICAL AND MILITARY TRAINING IN THE PUBLIC SCHOOLS.

A RRANGEMENTS have been made in relation to courses in Physical and Military Training during the summer vacation for teachers and prospective teachers throughout the

Courses in physical training will be conducted at St. John and Fredericton beginning July 12th next. This course consists of approximately 30 lessons of one hour each. At the completion of the course a certificate is granted by the Militia completion of the course a certificate is granted by the Milital Department. It is now necessary in order to obtain a license in this Province to have a certificate and after the end of the present school year all teachers must possess it to obtain advance of class, and at the end of four years from the same date all schools must provide physical training by qualified instructors.

The text book used is "Physical Exercises" for use in public elementary schools (1909)." It may be obtained from book sellers. This text book has been published by the Board of Education, England, and embodies the principles of Swedish drill. Whenever a sufficient number of teachers apply, a course in this subject at different centres throughout the Province will be provided for during the school terms.—in ordcourse in this subject at different centres throughout the Province will be provided for during the school terms, in order to enable the teachers to qualify with the least invonvenience, but teachers in remote districts should avail themselves of the summer schools to be provided at St. John and Prodesiston

Those proposing to attend these courses should, if possible, so notify the chief superintendent of Education by the 10th of June in order that he may insure that a sufficient number of instructors will be available. The place at which it is desired to take the course should be mentioned.

A course in physical fraining will also be provided at the Summer School of Science for the Maritime Provinces to be

held this year at Liverpool, N. S., beginning July 13th next.

three hundred and fifty dollars for rewards for physical training in the schools of New Brunswick for the coming year.

A course in Military Drill for male teachers and prospective teachers will be provided for those who desire a Grade A (Military) Certificate to qualify themselves for the organization and instruction of Cadet Corps at the Military Depot, Fredericton. They will be admitted only on the recommendation of the Chief Superintendent of Education, who must vouch for their professional standing; and as the number of candidates may be limited, those standing highest in the profession, with the best prospect of being able to organize and instruct a cadet corps, will receive the preference.

Application for admission should be made to the Chief Superintendent of Education not later than June 10th, quoting the class of license held, or better still (a) the school in which he is employed, (b) his class and length of service, (c) the railway station from which he will require a requisition

which he is employed, (b) his class and length of service, (c) the railway station from which he will require a requisition for free transportation and (d) his address, which should be sure to find him promptly at any time from the middle of June to the date on which he must start for the school which opens on the 12th of July at the Military Depot, Fredericton.

This course will last six weeks. It consists of scouting, musketry, military drill, tactics and other military subjects which will qualify a teacher as a cadet corps instructor, or for what is sometimes called a "Military A Certificate." Physical training as now authorized for the schools will form a part of this course.

A transport requisition will be forwarded to those authorized to take the course. This, when tendered to a ticket

agent will procure a first class railway ticket.

The actual expenses, such as cab fare, meals, etc., incurred in proceeding to and returning from the military depot,

curred in proceeding to and returning from the military depot, Fredericton, will be refunded by the Militia Department to those who obtain a certificate.

Those attending this course, will receive two dollars per day and will themselves arrange for their board and lodging. Those who do not already belong to a militia unit will be remired to wear uniforms as for Course of School Cadet Instrucquired to wear uniforms as for Corps of School Cadet Instructors, but without rank bandges.

The uniform authorized for Corps of School Cadet Instructors is as follows:

Jacket-Reefer or double breasted pattern of blue black cloth or serge of ordinary civilian sack-coat length fastened in front by two rows of four bottons each of Canadian Militia pattern. Shoulder straps—Blue crash with gilt-metal rank badges. Trousers of serge to match color of jacket, no stripe at seams. Cap—Field service, infantry, blue. The uniform be provided by those undergoing instruction.

It is suggested that the uniform be obtained after joining

A sword and belt should be provided.

Teachers who pass this course and become officers in a regiment of the militia, or officers of the Corps of School Cadet Instructors, and train a cadet corps which passes inspection, will receive a bonus from the Militia Department.

This Military "A" Certificate qualifies an officer for the rank of Lieutenant in an infantry regiment.

Those authorized to undergo the course are to report to the Adjutant, No. 5 Regimental Depot, Royal Canadian Regiment, at Fredericton, N. B., at 10 o'clock a. m., the 12th of July.

In addition to the bonus granted by the Militia Department some three hundred and fifty dollars has been allotted by the Executive Council Strathcona Trust for the coming school year for rewards for militia drill and rifle shooting in July. New Brunswick.
