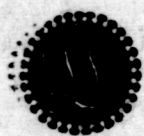

IN THE HIGH COURT OF JUSTICE.

In the Matter of the Farmers' Bank of Canada, and in the Matter of the Winding Up Act.

PURSUANT to the Order of Mr. Justice Riddell, made in this matter on the 24th day of December, 1910, a meeting of the Creditors of The Farmers' Bank of Canada will be held at the Board Room of the said Bank in the Stair Building, corner of Adelaide and Bay streets, Toronto, on Tuesday, the 17th day of January, 1911, at 11 o'clock in the forenoon, and on the same day at the same place, at 2.30 o'clock in the afternoon, a meeting of the shareholders will be held, the purpose of such meeting being that the wishes of the Creditors and Shareholders respectively may be ascertained as to the appointment of liquidators under the Winding Up Act.

NOTICE OF ASSIGNMENT, OF MEETING OF CREDITORS, AND TO FILE CLAIMS.
