NOTICE FOR PRIVATE BILLS.

#### (Extracts from Rules of the Senate.)

A LL applications to Parliament for Private Bills of any A LL applications to Parliament for Frivate Blus of any frature whatsoever, shall be advertised by a Notice pub-lished in the Canada Gazette; such Notice shall clearly and distinctly state the nature and objects of the application, and shall be signed by or on behalf of the applicants, with the address of the party signing the same; and, when the ap-plication is for an Act of Incorporation, the name of the proposed company shall be stated in the Notice. In cases where exclusive powers are asked, in addition to the Notice in the Canada Gazette aforesaid a similar Notice

In cases where exclusive powers are asked, in addition to the Notice in the Canada Gazette aforesaid, a similar Notice shall also be published in some leading newspaper in the principal city, town or village in each county or district and in each province or territory which may be affected by the passage of such Private Bills, according to the nature of the undertakings contemplated thereby. And, if the works of any company (incorporated or to be incorporated) are to be declared to be for the general advan-tage of Canada, such intention shall be specially mentioned in the Notice; and the applicants shall cause a copy of such Notice to be sent by registered letter to the clerk of each county council and of each municipal corporation which may be specially affected by the construction or operation of such works, and also, to the Secretary of the Province in which such works are or may be located, so as to reach those of-ficers not less than five weeks before the consideration of the petition by the Committee of Standing Orders; and a statu-tory declaration establishing the fact of such mailing shall be sent to the Clerk of the Senate.
