For an Act of Incorporation the name of the proposed Company shall be stated. If the works of any company are to be declared to be for the gen-earl advantage of Canada, the same shall be specifically men-tioned in the notice and a copy of such notice shall be sent by registered letter to the clerk of each county or munici-pality which may be specially affected by such works and also to the secretary of the province in which such works are or to the secretary of the province in which such works are or may be located; and proof of such service of notice shall be established by statutory declaration. In addition to the notice in the Canada Gazette afore-said, a similar notice shall be published in some leading newspaper ac follower:
