### NOTICE OF GRANTING SUPPLEMENTARY LETTERS PATENT.

PUBLIC NOTICE is hereby given that under Chapter Eighty-five of the Consolidated Statutes of New Brunswick, 1903, and amending Acts, Supplementary Letters Patent have been issued under the Great Seal of the said Province, bearing date the Twenty-first day of June, A.
