RULES AND PRACTICE OF THE LEGISLATIVE ASSEMBLY OF NEW BRUNSWICK.

PRIVATE BILLS.

78. A typewritten copy or printed copy of every Private Bill or Local Bill introduced into this House shall be filed with the Clerk of the House within ten days after the opening of the Session, and in case of failure to comply with this pro-vision the fee on the introduction of any such Private Bill shall be double the fee provided for in Rule 84 applicable to such Bill, and Local Bills introduced after ten days of the opening of the Session shall pay the same fee as a Private Bill.

such Bill, and Local Bills introduced after ten days of the opening of the Session shall pay the same fee as a Private Bill. 79. No Private Bill, or Bill making any amendments of a like nature to a former Act, shall be received by the House. unless a notice specifying clearly and distinctly the nature and objects thereof, has been published four successive weeks previous to the meeting of the Legislature, or to the intro-duction of the Bill, in some one of the newspapers published in the County interested in or to be affected by the measure. or in the locality where the parties affected. or the majority of them, reside; and when no newspaper is published in the such County or locality, then in some newspaper jublished in the such County or locality, then in some newspaper is published in the nearest adjoining County in which a newspaper is published, and also in the Royal Gazette. When the City or County interested in the measures or the locality in which the parties affected reside, is largely composed of a French population, then such notice shall also be published in a French news-paper if any be published in the Province. 80. In any County where no newspaper may be published, the Bill, in lieu of other local publication, may be read at the Assizes in the presence of the Grand Jury, or before the Municipal Council of the County interested in or affected by the Bill; and a Certificate of such reading shall be endorsed upon, or attached to the said Bill, by the Clerk of the Court. Town Council, or Municipal Council, as the case may be; sath Sep arate Petitions may be presented to the Flouse, setting forth in detail the object of the measure, and the reasons that may be urged for its adoption. 81. It shall be the duty of all parties seeking the inter-ference of the Legislature in any nrivate bill, to file, with the Clerk of the House, the evidence of their having compiled with the Rules and Standing Orders thereof. 84. No private Bill shall be received unless it shall be certified by the Receiver-Ceneral upo

When Bills are presented to the House any section or sections of which are intended to amend a section or sec-tions of previous Acts, either by adding to or striking out therefrom any words or clauses, the intended amendment should be first stated and the section or sections amended as proposed should then be set out in full. 156. Proof of publication of Bills advertised under Rule 79 of the Rules and Practice of this House must be by affidavit or Solemn Declaration, and the Clerk shall cause this rule to be published in the Royal Gazette over his sig-nature weekly from the first week in December in each year until the meeting of the Legislature.
