WITNESS, Our Right Trusty and Well-Beloved the Right Honorable Sir FREDERICK ARTHUR STANLEY, Baron Stanley of Preston, in the County of Lancaster, in the Peerage of the United Kingdom; Knight Grand Cross of Our Most Honorable Order of the Bath; Governor General of Canada.

At Our Government House, in Our City of OTTAWA, this TWENTY-THIRD day of SEPTEMBER, in the year of Our Lord, one thousand eight hundred and ninety-two, and in the Fifty-sixth year of Our Reign.
