# Notice to Holders of Timber Licenses.

CROWN LAND OFFICE, 18th July, 1894.

THE attention of all holders of Timber Licenses is called to Section 19 of the Timber Regulations which reads s follows:—

"19. No Spruce or l'ine Trees shall be cut by any Licensee under any License, not even for piling, which will not make a log at least 18 feet in length and ten inches at the small end; and if any such shall be cut, the Lumber shall be liable to double Stumpage and the License be forfeited."

And all Lieensees are hereby notified that for the future the provisions of this Section will be rigidly enforced.
