

### Notice of Application for Letters Patent

NOTICE is hereby given that application will be made by the applicants hereinafter named to His Honor the Lieutenant Governor in Council for a grant of Letters Patent under the Great Seal of the Province of New Brunswick, according to the provisions of "The New Brunswick Joint Stock Companies' Act, 1893," incorporating the applicants and such other persons as may hereafter become shareholders in the proposed Company, a body corporate and politic, under the name and for the purposes hereinafter mentioned.

1. The proposed name of the Company is "THE MUSQUASH LUMBER COMPANY, (Limited)."
