Notice of Application for Letters Patent.

NOTICE is hereby given, that application will be made by the undersigned to flis Honor the Lieutenant Governor in Council for Letters Patent under the Great Seal, constituting the said undersigned applicants and such other persons as may become shareholders in the Conpany thereby created, a body politic and corporate, under the provisions of "The New Brunswick Joint Stock Companies' Act, 1893."

1. The proposed corporate name of the Company is "THE SAINT GEORGE ELECTRIC COMPANY, (Limited)
