### Notice of Granting Supplementary Letters Patent.

PUBLIC Notice is hereby given, that under "The New Brunswick Joint Stock Companies' Act, 1893." Supplementary Letters Patent have been issued under the Great Seal of the Province of New Brunswick, bearing date the twenty seventh day of April, A. D. 1894, extending the powers of "THE RESTIGOUCHE ELECTRIC AND TELEPHONE COMPANY" for the following

purposes:—To extend their Telephone line system from the several points to which their present lines extend to the following places: Belledune, Armstrong's Brook, Jacquet River, Nash's Creek, Black Point, New Mills, River Charlo, Eel River Crossing, Charlo Station, Upper Charlo, Dalhousie Junction, Dalhousie, Dundee, Balmoral, Campbellton, Restigouche Room, Head of Tide, Colebrook Settlement, Glencoe Flat Lands, Dawsonville, and Robinsville, all in the County of Restigouche; and also to connect with any Telephone line established outside of the County, subject however, to certain conditions in the original Letters Patent to the said Company, dated the 15th day of May, 1893, and more particularly defined therein.
