Escheat of Mining License.

In the matter of a Mining License, between Her Majesty the Queen and F. E. Demill, bearing date the 30th July, 1879.

NOTICE is hereby given, that application will be made at the next Session of the New Brunswick Legislature, for an Act to incorporate a Company to be called "The Colonial Iron and Coal Company, (Limited)," with a capital stock amounting and Coal Company, (Limited)," with a capital stock amounting to One million of dollars, having power to increase to Two millions, one half the shares to be preferred and the remainder common stock, and having authority to issue Bonds to the amount of the capital paid up.
