HEREAS by an Act made and passed in the fifty fourth year of the Reign of Her present Majesty, intituled "An Act respecting the Office of Queen's Printer and the Public Printing," it was amongst other things, enacted that the said Act should not go into operation until proclaimed by the Lieutenant Governor under the authority of an Order in Council;
