### Notice of Granting Supplementary Letters Patent.

PUBLIC NOTICE IS HEREBY GIVEN, That under "The New Brunswick Joint Stock Companies' Act, 1893," and amending Acts, Supplementary Letters Patent have been issued under the Great Seal of the Province of New Brunswick, bearing date the fourth day of June, A. D. 1898, extending the powers of "The Little Salmon River Telephone Company, (Limited)," for the following purposes :-

lowing purposes :--The erection, construction, maintenance and operation of lines of telephone communication between said Company's chief place of business at Sussex, in the County of King's, in the Province of New Brunswick, and the Village of Havelock Corner, in the Parish-of Havelock, in said County of King's, and also between Clover-Hill in the Parish of Sussex, in the County of King's aforesaid, and the Office of V. S. White & Co. in the City of Saint John, in-said Province, and also between Mechanic Settlement in said. County of King's and the Village of Alma, in the County of Albert in said Province, and also between said Village of Alma and the-Village of Point Wolfe in said County of Albert, with power to-enter from time to time upon any public streets, roads, squares, open plots of ground or highways in any City or County in said. Province lying between the terminal points aforesaid respectively, and to break up and open such public streets, roads, squares, open-plots of ground or highways, or any part thereof, for the purpose-of erecting and maintaining poles and posts, and stringing and manutaining wires for telephone purposes, and for renewing and repairing the same. And the Company may have, use, exercise, possess and enjoy all such rights, franchises and privileges as are or shall be proper, necessary and incident to said purposes and objects. Subject, however, to certain conditions in the original Letters Patent to the said Company, dated the sixth day of July, A. D. 1896, and more particularly defined therein ; and subject also to certain conditions and terms in the Supplementary Letters Patent issued hereunder.
