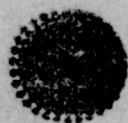

WHEREAS the General Assembly of this Province stands prorogued to the thirtieth instant, I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued accordingly to Thursday the fifth day of January next.

PUBLIC NOTICE IS HEREBY GIVEN, That the applicants hereinafter named, will apply by petition to His Honor the Lieutenant Governor in Council for the grant of a Charter by Letters Patent under the Great Seal of the Province of New Brunswick, according to the provisions of "The New Brunswick Joint Stock Companies' Act, 1893," and the Acts in amendment thereof incorporating the applicants and such other persons as may hereafter become shareholders of the Company, a body corporate and politic, under the name and for the purposes hereinafter mentioned.

1. The proposed name of the Company is "THE CARLETON CREAMERY COMPANY, (Limited)."

2. The objects and purposes for which the incorporation of the Company is sought are—

(1.) The buying, manufacturing and selling of all kinds of dairy products.

(4.) The purchasing and acquiring real and personal property of every kind as may be considered necessary for the purposes aforesaid.

3. The Office and chief place of business of the Company is to be at the Parish of Northampton, in the County of Carleton and Province of New Brunswick.

4. The amount of the Capital Stock of the Company is to be Ten thousand dollars, divided into four hundred shares of Twenty-five dollars each, of which two hundred shares have been actually subscribed.

Rules and Practice of the House of Assembly.

PRIVATE BILLS

At the last Session of the Legislative Assembly of the Province of New Brunswick, Rule 78 was repealed, and the following substituted in lieu thereof:—

"78.—(1) No Private Bill shall be received by this House after the tenth day from the opening of the Session, both inclusive,

(2) A typewritten or printed copy of every Private Bill so to be introduced shall be filed with the Clerk of the House at least three days before the opening of the Session; and in case of failure to comply with this provision, the fee on the introduction of any such Bill shall be double the fee provided for in Rule 84, applicable to such Bill."
