PROCLAMATION.

WHEREAS upon the report of the Surveyor General of the said Province, it has been made to appear to the satisfaction of the Lieutenant-Governor in Council, that Gold has been discovered on Cross Creek, in the Parish of Stanley, in the County of York;

AND WHEREAS it has also been reported by the said Surveyor General, that numerous applications have been made for Mining Areas in that locality, under the "General Mining Act" of 1891, and that in his opinion, in order to prevent complications arising, and to satisfactorily regulate, control and equitably deal with such applications, it is desirable that the hereinafter bounded and described locality be, by Proclamation, declared to be a Gold District, under the provisions of Section 8 of the said "General Mining Act" of 1891;

I do therefore, by virtue of the provisions of the said "General Mining Act" of 1891, and amendments thereto, proclaim the district situate in the County of York, limited and bounded as follows, that is to say:—

Beginning at the Mouth of Cross Creek, where the Northern line of the Parish of St. Marys, in the County of York, intersects same, thence running by the magnet West $6\frac{1}{2}$ miles to the Douglas Parish line, thence North along said line 10 miles, thence East 10 miles, South 10 miles to St. Marys Parish line aforesaid, and thence West $3\frac{1}{2}$ miles to place of beginning; to be a Gold District under the provisions of said Act and amendments thereto.

Given under my Hand and Seal at Fredericton, the twenty-second day of March, in the year of our Lord one thousand eight hundred and ninety-nine, and in the sixty-second year of Her Majesty's Reign.

NOTICE OF GRANTING LETTERS PATENT.

PUBLIC NOTICE IS HEREBY GIVEN, That under "The New Brunswick Joint Stock Companies' Act, 1893," and amending Acts, Letters Patent have been issued under the Great Seal of the Province of New Brunswick, bearing date the twenty-second day of March, A. D. 1899, incorporating Alexander Walker Ogilvie, of the City of Montreal, in the Province of Quebec, Senator; James George Ross, of the same place, Chartered Accountant; William Barclay Stephens, of the same place, Manager of the Western Loan and Trust Company; William Lovitt Hogg, of the same place, Manager of the Investment Company; Frank A. Baird, of the City of Saint John, in the Province of New Brunswick, Mining Broker; and Edward P. Raymond, of said City of Saint John, Barrister at Law; for the following purposes:—

To prospect and search for, explore, open, develop, work and maintain gold, silver, copper, coal and iron mines, and mines of every other description, and to carry on the business of mining of every description, including crushing, washing, smelting, reducing and otherwise treating the products of mines, and to acquire by purchase, or otherwise mine and work, manufacture and make merchantable gold, silver and other ores and deposits and other minerals and metallic substances and compounds of all kinds, stone, oil, coal, earth or matters or things whatsoever, and to sell and dispose of the same, or any of the same.

To purchase and acquire certain mineral lands, leases, licenses and rights over minerals in the Province of New Brunswick and also to purchase and acquire lands and properties situate in British Columbia, or any Province or district in the Dominion of Canada.

To purchase and otherwise acquire and deal in real and personal properties of all kinds, and in grants, concessions, leases, options, licenses or authorities of and over lands, mines, ores,

mineral rights, mineral properties, surveys and timber rights, buildings, factories, furnaces, plant and machinery, trade marks, easements and privileges, rights of way, water and other rights in New Brunswick, and in British Columbia and elsewhere in the Dominion of Canada, and any claims against any property or against any persons or Company, and either solely or jointly with others, to pay for any such properties and things either in shares of the Company, or partly in cash and partly in shares, or otherwise.

To construct, carry out, maintain, improve, alter, manage, work, control and superintend any trails, roads, ways, tramways, bridges, walls, reservoirs, water courses, aqueducts, wharves, furnaces, saw mills, crush works, hydraulic works, telegraphs, telephones, gas works, factories, machinery, warehouses, ships, vessels and other works and conveniences, except railways, which may seem directly or indirectly conducive to, expedient and useful for any of the purposes of the Company, and to contribute to, subsidize or otherwise aid or take part in any such operation.

To use steam, water, electricity, or any other power as a motive power or otherwise.

To improve, manage, develop, lease, mortgage, sell, dispose of, or otherwise deal with all or any part of the property and rights of the Company, (including the granting of powers to work any mines or claims or patents of the Company), upon any terms and with power, subject to the provisions of Section 73 of the above mentioned Act, to accept as a consideration therefor any shares, stocks, debentures or securities of any other Company.

To acquire by purchase, lease, license or otherwise, absolutely or conditionally, the rights of either generally or exclusively over any area or areas of or in all any patent rights or processes, or mechanical or other contrivances, useful or supposed to be useful, for any of the purposes of the Company, and to deal with and dispose of the same or any interest therein respectively.

To enter into any agreement for sharing profits, union of interests, or co-operation, with any person or Company, carrying on or about to carry on any business or transaction capable of being conducted so as to benefit the said Company.

To purchase or otherwise acquire and undertake all or any part of the business, property and liabilities of any person or Company carrying on any business which this Company is authorized to carry on, or possessed of property suitable for the purposes of this Company.

To pay out of the funds of the Company all expenses of or incidental to the formation, registration, and advertising of the Company, and to remunerate any person or Company for services rendered or to be rendered in placing of the shares in the Company's Capital, or any debenture or other securities of the Company in or about the formation or promotion of the Company or the conduct of its business; by the name of "The Montreal Boundary Creek Mining Company, (Limited)," with a total capital of Two Million Dollars, divided into Two Million shares of One Dollar each.
