

along the said southern side line of the said lot J, to the rear line of the first tier of lots; and thence northerly along the said rear line to the southeastern angle of lot six, granted to James O'Donnell in the second tier; and thence westerly along the southern line of said lot six to the eastern boundary of the parish of Richmond—at the Town Hall in the Town of Woodstock.

*“Number Two.*—For that part of the parish not included in sub-district number one—at or near the residence of John Scott.

*“In the Parish of Brighton, Number Eleven.*—For that portion of the parish lying north and east of a line commencing at the northwest angle of the said parish, and following the various courses of the Coldstream till it strikes the southwest angle of lot number one, on the eastern side of Coldstream, granted to Benjamin Laskay; thence along said Laskay's south line in an easterly direction till it strikes the west line of lot number eleven, on the north side of the Becaguimec, granted to Joseph Swim; thence southerly along Swim's west line to Becaguimec River; thence following up stream the various courses of said river and its southern tributary (commonly called “South Branch”) to the County line—at or near Carlisle.

*“Number Twelve.*—For the remainder of the parish—at Hartland.

*“Number Sixteen.*—For that part of the parish which is east of sub-district number fifteen, and that part of the parish of Aberdeen lying east of range five of said parish of Aberdeen—at or near Foreston post office.

*“In the Parish of Aberdeen, Number Seventeen.*—For all the remaining part of the parish of Aberdeen lying west of range five of said parish, and not included in sub-district sixteen—at or near William Love's.”

And substituting in lieu thereof the following:

*In the Parish of Woodstock, Number One.*—For that part of the parish of Woodstock lying north of the Houlton Road (so called) excepting what is known as the Town of Woodstock—at or near the Court House.

*Number Two.*—For that part of the parish of Woodstock lying south of the said Houlton Road, not included in sub-district number one—at or near the old Extract Works,

*In the Parish of Brighton, Number Eleven.*—For that part of the parish lying north and east of a line commencing at the south line of the parish of Aberdeen, near Gilmour's mill, on the Coldstream, and following the said Coldstream down stream until it strikes the southern line of the parish of Peel; thence along the said south line of the parish of Peel to the rear of the Saint John River lots; thence along the rear of the said Saint John River lots to the south or rear line of Jesse Estabrooks' lands in Ashland; thence along the rear of the base line of the Ashland lots; and thence along the prolongation until it strikes the rear of the lands fronting on the main Becaguimec River; thence southerly along the rear of lands fronting on said river and its tributary (commonly called “South Branch”) to the York County line—at or near Rockland.

*Number Twelve.*—For the remainder of the parish of Brighton—at Hartland.

*Number Sixteen.*—For that part of the parish of Kent which is east of sub-district number fifteen, and that part of the parish of Aberdeen lying east of range four of said parish of Aberdeen—at or near Foreston post office.

*In the Parish of Aberdeen, Number Seventeen.*—For the remainder of the parish of Aberdeen lying west of range four of said parish, and not included in sub-district number sixteen—at or near William Love's.

8. Said Section 101 of “The New Brunswick Elections Act of 1889” is hereby further amended in that part thereof which relates to the parishes of Wickham and Brunswick, in the County of Queens, and divides the said parishes into sub-districts under the said Section by striking out the words:

*“Number Five.*—For the parish of Wickham—at or near Archilus Bulyea's.

*“Number Seven.*—For the parish of Brunswick—at or near Zebulon Currey's.”

And substituting in lieu thereof the following:

*Number Five.*—For the parish of Wickham—at or near the Public Hall in Shannon.

*Number Seven.*—For the parish of Brunswick—at or near the new school house, Canaan's Forks.

9. Section 10 of the Acts of Assembly, 61 Victoria, Chapter 36, is hereby amended in that part thereof which relates to the parishes of Perth, Gordon, and Lorne in the County of Victoria, and divides the said parishes into sub-district under the said Section, by striking out the descriptions therein of sub-districts number seven, number eight, number nine, number ten, number eleven, number twelve, number thirteen; and substituting in lieu thereof, the following:

*Number Seven.*—Beginning at the southwest angle of lot No. 26 granted to Alexander S. Malcolm in Lower Kintore Settlement; thence southeasterly along the northeastern line of said lot to the Kintore Settlement road; thence easterly along said road to the western line of lot No. 40 granted to Thomas Cumming; thence northerly to the northwest angle of said lot; thence easterly to the northeast angle of lot number 46 granted to John Cumming; thence southerly to the southwest angle of lot number 54, granted to William S. Cumming; thence easterly along the southern line of said lot number 54, and its eastern prolongation to the Gordon parish line; thence along the same, southerly to the Carleton County line; thence westerly along same to the River Saint John; thence up same to the southern boundary of polling district number seven; and thence along the southern and eastern boundary thereof, to the place of beginning—at or near William Miller's at the mouth of Muniac stream.

*Number Eight.*—All the remaining part of the parish of Perth—at or near Perth Centre.
