### Wide Tires on certain Vehicles.

"(2) On and after the first day of May, in the year of our Lord hundred and ninety vehicle loaded with stone, gravel, sand, or other material of any kind or nature with atsoever, when the load exceeds in weight one and a half tons, shall, when used and passing over or along any Highway, be provided with tires not less than four inches wide; the owner or person in charge of any such vehicle, shall, for every offence against this Section, incur a penalty of five dollars."
