His Honor the Lieutenant-Governor in Council has been His Honor the Lieutenant-Governor in Council has been pleased to make the following Order respecting the incorpor-ation of Companies by Letters Patent under the Act 56th Victoria, Chapter 7, and amendments thereto, which is to take effect from the date hereof, and all previous Orders and Regulations relating thereto are rescinded :--1. The Honorable the Provincial Secretary is hereby desig-nated as the Officer charged with the issue of Letters Patent and Supplementary Letters Patent ; and the Department of the Honorable the Provincial Secretary as the Department through which such issue shall take place. 2. The signatures of the Subscribers to the Petition for Letters Patent or Supplementary Letters Patent, or to the Memorandum of Association, shall be verified by affidavit to the satisfaction of the Provincial Secretary. 3. - 3. The following is the schedule of rees payable under the 93rd Section of the said Act ;-(1) When the proposed Capital Stock of the Company is \$5,000 or less, the fee to be Thirty dollars, (\$30 00).
