

NOTICE IS HEREBY GIVEN. That application will be made by the applicants hereinafter named to His Honor the Lieutenant Governor in Council for a Grant of Letters Patent under the Great Seal of the Province of New Brunswick, according to the provisions of the Act of the General Assembly, 56 Victoria, Chapter 7, intituled "The New Brunswick Joint Stock Companies' Act, 1893," incorporating the applicants and other such persons as may be members in the proposed Company, a body corporate and politic under the name and for the purposes hereinafter mentioned.

1. The name of the Company shall be "The Miramichi Fish and Game Club"

2. The objects for which Incorporation is sought are :

(a.) To promote the health and recreation of its members by the pursuit of fishing and hunting.

(b.) To purchase and acquire waters, lands and properties within the Province of New Brunswick, and to erect thereon all such buildings that may be found necessary for the accommodation of its members.

(c.) To acquire and hold the right, to be exercised by the members, to fish its waters and shoot game on its lands, and hold all licenses necessary for that purpose.

(f.) To take such action or proceedings as may be necessary to protect the fish in its waters and the game on its lands.

(g.) To improve and develop generally its property in the interests of the Club, and to have and exercise under the laws of the Province all rights, powers and authorities as are incidental or conducive to the attainments of the above objects, or any of them.

3. The Office or chief place of business is to be established at Newcastle, in the County of Northumberland, New Brunswick.

4. The amount of the Capital Stock of the said Club is to be Twenty thousand dollars, divided into twenty shares of One thousand dollars each, of which eleven shares are actually subscribed.

5. Permission will be sought to hold the annual meetings of the Club and special meetings of the Directors and also of the Shareholders without the Province of New Brunswick.
