or by reason of such altered assessment, a statement showing such addition or alteration to the Parish Clerk, who shall correspondingly correct the list previously furnished to him and preserve on file the notification so given by the Assessors; and when an election is to be held the Parish Clerk shall furnish the chairman, unless he himself acts as chairman, with such list as corrected and amended, and any Assessor failing to furnish such list, or additions or amendments thereto, as herein required, and any Parish Clerk failing to furnish such list, or list so amended as aforesaid, to the chairman as aforesaid, shall be liable to a penalty of not more than one hundred dollars, nor less than twenty dollars, to be recovered before two Justices of the Peace. The Assessors, in the list required to be so furnished by them to the Parish Clerk shall state which of the persons named in such list are non residents

of the County.

2. Section 25 of "The Municipalities Act," 61 Victoria, Chapter 34, is hereby amended, by inserting after the word "or" in the seventh line thereof, the words "if a resident of the parish," and by inserting in the eighth line thereof, after the word "amount," the words "or if not so resident, on real property to the amount of one hundred dollars." And further, by adding at the end of the Section the following: "Provided, however, that in the County of Gloucester any resident retenaver of a parish, rated on income or personal property ratepayer of a parish, rated on income or personal property to the amount of fifty dollars, or on income and personal pro-perty together to the amount of fifty dollars, shall be envitled

to vote at the election of councillors."

3. No person shall be elected a councillor for any parish who is not a resident of the County in which such parish is

4. No non-resident of any County shall be entitled to a vote therein at any election in any parish for councillors, under "The Municipalities Act," 61 Victoria, Chapter 34, unless his taxes assessed against him with said parish shall have been paid at least one week before the day of such election. If required by the chairman or any elector, any non resident elector shall, before being entitled to vote, take the following oath, which the chairman is hereby authorized to administer: "I am the person named in the Electors' list and have paid all taxes assessed againt me within this parish, and I paid the same at least one week before this day.—So help me God."

5. The Act of Assembly Chapter 4, 62 Victoria, is hereby

6. Section 95 of "The Municipalities Act," 61 Victoria

Chapter 34, is hereby amended, by adding as sub-Section 45 the following: 45th. To regulate the breaking of roads in winter and to determine the width thereof.
