# CAP. XXVIII.

## An Act to amend "The Schools' Act, 1900."

Sec. Preamble.

2 Trustees; when term of office 1 Poll tax for Term ending 30th expires. 3 Schedule B amended. June next to be \$1.

Passed 3rd April, 1901.

WHEREAS by the provisions of "The Common Schools' Act, 1871," the last School year ended on the 31st day of Decem-ber, 1900, and by the provisions of "The Schools' Act, 1900," the next School year begins on the first day of July, 1901, and by reason thereof it is necessary to make provision for the collection of a Poll Tax for the interim Term, which began on the first day of January last, and will end on the 30th day of June next, and it is also necessary to make other provisions as hereinafter contained : as hereinafter contained :

Be it therefore enacted by the Lieutenant Governor and

Legislative Assembly, as follows :-1. For the School Term, which will expire on the said 30th day of June next, the Poll Tax to be assessed shall be one dollar, and such Poll Tax may be assessed for such School

Term notwithstanding anything contained in Section 23 of the said "The Schools' Act, 1900" 2. The Trustees who would have gone out of office at the annual meeting which would have been held on the second Saturday in October next, but for the date of holding the annual school meeting having been changed by the said Act, shall go out of office at the annual school meeting to be held shall go out of office at the annual school meeting to be held on the third Saturday in June next, and those who would have gone out of office on the second Saturday in October, A. D. 1902, shall go out of office on the third Saturday in June, A. D. 1902, and so on from year to year. 3. Schedule "B" to the said Act is hereby amended by striking out the words and figures "52nd Victoria, Chapter 13, all but Section 13," and inserting in lieu thereof the words and figures "52nd Victoria, Chapter 15, all but Section 13."

#### CAP. XXIX.

An Act in further amendment of "The Bills of Sale Act, 1893." Sub-sec. (1) of Section 6, amended.
