Lieutenant Governor in Council, and such portion thereof as the Lieutenant Governor in Council may hereafter determine may be reimbursed to the said pistrict. It shall be the duty of every parent or guardian having the charge or custody of any minor under the age of sixteen years within said district, upon being notified or requested to have such minor vaccin-ued to forthwith bring such minor to the office or place ated, to forthwith bring such minor to the office or place designated by the Local Board of Health, and to have such minor then and there vaccinated, unless the officer shall declare such vaccination unnecessary or inexpedient, and any notice or request requiring such minor to be vaccinated, or to so attend as aforesaid to be vaccinated, may be made of and directed to such parent or guardian instead of to such minor in person. In case of the neglect or refusal of any person to attend and submit to vaccination in accordance with this regulation, or of any parent or guardian responsible for the attendance of any minor as aforesaid to have such minor attend and submit to such vaccination as aforesai 1, the Chair-man of the Local Board of Health for the said district shall man of the Local Board of Health for the said district shall and may exercise all the powers and authority in such case in him vested under and by the Public Health Act, 1898, and all officers appointed or designated by the Local Board of Health, or whose duty it shall be to assist and aid in the carrying out of this regulation, shall for such purpose have all the powers, rights and authorities by said Act given and provided, and all persons disobeying or violating the provisions of this regulation shall be subject to the penalties by said Act provided. provided.

REGULATION 3. Whenever in any health district within the Province, other than a City or Town, it shall be found by the Local Board of Health of such district that a case of smallpox exists therein, it shall be the duty of such Local Board of Health to take immediate steps to isolate the disease and prevent its spreading, as far as possible, using for that pur-

pose all the powers in them vested under and by the Public Health Act, 1898, and such Local Board shall also provide for the vaccination by the officer or officers of said Board of all Health Act, 1898, and such Local Board shift also provide for the vaccination by the officer or officers of said Board of all persons within their district requesting to be vaccinated. It shall be the duty of the officer of such last mentioned Local Board who shall be appointed or designated for that purpose, to notify and require all persons within the said last mentioned district whom he shall have reason to believe likely or liable to have been infected with the contagion of smallpox, to be vaccinated compulsorily if necessary under the provisions of said Act, and for the purpose of securing such compulsory vaccination in the case of such person such officer shall possess all the powers and authority given and provided by the said Act, and any such person being required by such officer as aforesaid to be so viccinsted, and refusing or failing to comply with such request, shall be subject to the penalties for such refusal provided by said Act. The cost and charges of all vaccination under this regulation shall be defrayed by the Contry, or in the case of the City and County of Saint John by the City and County, comprising such district, sub-ject to reimbursement of such part thereof by the Govern-ment as the Lieutenant-Governor in Council may hereafter allow. allow.

REGULATION 4 It shall be the duty of the Board of Health of each and every health district in the Province, to forth with appoint officers whos- duty it snall be to vaccinate all applicants, at such places and between such hours as the Board shall determine, upon payment by the person so vaccinated of a fee not exceeding fifty cents, and to forth with give public notice of the appointment of such officers, and of the places where and the times within which persons may be so vaccinated.
