NOTICE IS HEREBY GIVEN, That application will be made by the applicants hereinafter named, to His Honor the Lieutenant-Governor in Council for the granting of Letters Patent, under the Great Seal of the Province of New Brunswick, in accordance with the provisions of "The New Brunswick Joint Stock Companies' Act, 1893," and amending Acts, incorporating the applicants and such other persons as may become shareholders in the proposed Company, a body corp rate and politic, under the name and for the purposes hereinafter named.
