NOTICE IS HEREBY GIVEN. That the persons hereinafter mentioned will apply to His Honor the Lieutenant-Governor in Council, for the Grant of a Charter of incorporation, by Letters Patent, under the Great Seal, according to the provisions of "The New Brunswick Joint Stock Companies' Act, 1893," and Acts in amendment thereof and in addition thereto, incorporating the applicants and such other persons as may hereafter become shareholders in the proposed Company, a body corporate and politic, under the name and for the purposes hereinafter set forth.

1. The proposed corporate name of the Company is the "JOHN PALMER COMPANY, Limited."

2. The objects for which incorporation is sought are:

(a) To purchase and acquire the Tanneries and Larrigan Factory, with their respective plant and machinery, lands and premises, whether freeholds or leaseholds, or both, with the buildings and improvements thereon, now owned by John Palmer, in the City of Fredericton, in the County of York and Province of New Brunswick, and the Larrigan and Shoepack manufacturing business heretofore carried on by the said John Palmer throughout the Dominion of Canada, and also all trade marks, patents, patent rights, licenses, franchises, personal property, choses in action, rights and effects belonging to the said John Palmer, and the good will of the said business.

(b) To carry on the business of manufacturing and selling leathers, larrigans, shoepacks and other footwear of all kinds, and all things in connection therewith and incidental thereto, and to establish and maintain branch factories or warehouses in any part of Canada or elsewhere.

(c) To purchase and acquire the stock in trade, real and personal property, franchises, patents, patent rights, licenses, effects and assets of any person or persons or incorporated company now or hereafter carrying on any manufacturing or mercantile business, or take security thereon, and to continue same when so acquired, and to sell and dispose of same when so acquired and every part thereof.
