IN TESTIMONY WHEREOF, We have caused these Our Letters to be made Patent and the Great Seal of Canada to be hereunto affixed. **WITNESS**, Our Right Trusty and Right Well-beloved Cousin the Right Honourable Sir **GILBERT JOHN ELLIOT**, Earl of Minto and Viscount Melgund of Melgund, County of Forfar, in the Peerage of the United Kingdom, Baron Minto of Minto, County of Roxburgh, in the Peerage of Great Britain, Baronet of Nova Scotia, Knight Grand Cross of Our Most Distinguished Order of St. Michael and St. George, etc., etc., Governor General of Canada.

His Honor the Lieutenant-Governor in Council has been pleased to make the following Order respecting the Incorporation of Companies by Letters Patent, under the Act 56 Victoria, Chapter 7, which is to take effect from the date hereof:—

Sub-section (11) of Section 3, of Regulations and Tariff, is amended, and to read as follows:

(11) On Supplementary Letters, when application is to increase the Capital Stock, the fee shall be payable upon the increased amount for which Letters are applied for according to the Scale of Fees of 15th September, 1899.
