HIS Honor the Lieutenant-Governor in Council has been pleased to make the following Order respecting the Incorportion of Com-panies by Letters Patent. under the Act 56 Victoria, Chapter 7, which is to take effect from the date hereof :-

Sub-section (11) of Section 3, of Regulations and Tariff, isamended, and to read as follows:

(11) On Supplementary Letters, when application is to increase the Capital Stock, the fee shall be payable upon the increased amount for which Letters are applied for according to the Scale of Fees of 15th September, 1899.
