Any Dentist or Dental Surgeon practising dentistry in any form in the Province of New Brunswick, whose name does not appear in the list above, is not registered as per Section 18 of "The New Brunswick Dental Act, 1890," and is liable to prosecution under said Act, and cannot legally collect fees for services rendered, as per Section 30 of "N. B. Dental Act, 1890," which reads as follows:—"No person shall be entitled to recover any charges in any Court of Law for services as Dentist or Dental Surgeon, or for any medicines which he shall have both prescribed and supplied, unless he shall prove upon trial that at the time the services were performed, or the medicines prescribed and supplied, he was registered under this Act."
