WHEREAS the General Assembly of this Province stands prorogued to Thursday the second day of January instant, I have thought fit further to prorogue the said General As-sembly, and the same is hereby prorogued accordingly to THURSDAY the thirteenth day of FEBRUARY next.

Given under my Hand and Seal at Fredericton, the first day of January, in the year of our Lord one thousand nine hundred and two, and in the first year of His Majesty's Reign.

NOTICE IS HEREBY GIVEN, That the persons hereins fter mentioned will apply to His Honor the Lieutenant-Governor in Council, for the Grant of a Charter of Incorporation, by Letters Patent, under the Great Seal, according to the provisions of "The New Brunswick Joint Stock Companies' Act, 1893," and Acts in amendment thereof and in addition thereto, incorporating the applicants and such other persons as may hereafter become share-holders in the proposed Company, a body corporate and politic, under the name and for all the purposes hereinafter set forth. 1. The proposed corporate name of the Company is "SAINT JOHN MILLING COMPANY, Limited."

mechanical contrivance, useful or supposed to be useful, for the purposes of the proposed Company, and to deal with and dispose of the same or any interest therein.
