### NOTICE OF GRANTING LETTERS PATENT.

PUBLIC NOTICE IS HEREBY GIVEN, That under "The New Brunswick Joint Stock Companies' Act, 1893," and amending Acts, Letters Patent have been issued under the Great Seal of the Province of New Brunswick, bearing date the seventeenth day of March, A. D. 1902, incorporating Joshua Peters, Manufacturer; Clifford W. Robinson, Barrister; Frederick W. Sumner, Merchant; John W. Y. Smith, Merchant; John H. Harris, Merchant; Hon. Peter McSweeney, Merchant; Lester H. Higgins, Merchant; David I. Welch, Barrister; and William H. Edgett, Merchant; all of Moncton, in the County of Westmorland and Province of New Brunswick; for the following purposes, namely:—

To build, buy, acquire, own, sell, lease, hire, charter, control, sail and navigate one or more British steamboat or steamboats and other vessels.

To carry and convey passengers, goods, wares and merchandise, and to do the work of common carriers by steamers or other conveyances, and to provide, furnish and sell food, refreshment and entertainment, on water or land, in connection with their business as passenger carriers; and to build, buy, acquire, lease, own and sell wharves, piers and warehouses and other structures to be used in connection with steamboating and forwarding business.

To carry on the business of towage in all its branches, and to supply, furnish and sell fresh water to all steamers and other vessels.

To mortgage, hypothecate or otherwise dispose of all or any of the Company's interests or possessions.

To hold, acquire, purchase or obtain and hold by any lawful means any and all lands, tenements and hereditaments necessary for the business of the Company, and to do all such things as are incident to the purposes aforesaid; by the name of "SHEPODY NAVIGATION COMPANY, (Limited)"; with a total Capital Stock of Fifteen thousand dollars, divided into one hundred and fifty shares of One hundred dollars each.

NOTICE IS HEREBY GIVEN, That application will be made by the applicants hereinafter named to His Honor the Lieutenant-Governor in Council for a grant of Letters Patent, under the Great Seal of the Province of New Brunswick, according to the provisions of the Act of the General Assembly 56th Victoria Chapter 7, intituled "The New Brunswick Joint Stock Companies' Act, 1893," and the Acts in amendment thereof, incorporating the applicants and such other persons as may hereafter become shareholders in the said proposed Company, a body corporate and politic under the name and for the purposes hereinafter mentioned.

1. The name of the Company is to be the "MAY QUEEN STEAMSHIP COMPANY, (Limited)."

2. The objects for which incorporation is sought are:

(a) To purchase or otherwise acquire the Steamer "May Queen," registered at the Port of Saint John, with all requisite equipment for the same, and to equip, own, control, sail, charter, let, hire and manage the said Steamer, and such other steamer and steamers, if any, as may be hereafter purchased, built, owned, leased, or otherwise acquired or controlled by said Company for the conveyance of passengers, mails and freight upon the waters of the River Saint John and its tributaries, and other waters within the Province of New Brunswick.

(b) Also to build, purchase, charter or otherwise acquire steamers, vessels and other conveyances using steam or other motive power, and to equip, own, hold, control, manage, charter, let and hire the same for the conveyance passengers, mails and freight, and for other purposes.

(c) To purchase, lease or otherwise acquire lands, tenements and hereditaments, and construct, build, purchase, take on, lease or otherwise acquire wharves, piers, docks, buildings or other property or works, and such concessions, licenses and rights in respect of any of the same capable of being advantageously used in connection with the business of the Company.

(d) To carry, convey or transport passengers, mails and freight of all kinds, and to do the work of common carriers by steamers, vessels and other conveyances, and in connection therewith to provide, furnish and sell food, refreshments and entertainment on water and land.

(e) To mortgage, hypothecate, sell or in any way dispose of all or any of the Company's property, interests or possessions as may be deemed desirable by the Company.

(f) To hold, purchase, or otherwise acquire, sell, assign, transfer, mortgage, pledge or otherwise dispose of shares of the capital stock, and bonds, debentures or other evidences of indebtedness created by any other corporation or corporations, and while the holder thereof to exercise all the rights and privileges of ownership including the right to vote thereon.

(g) To do any or all of the things above set forth as objects, purposes, powers, or otherwise, to the same extent and as fully as natural persons might or could do as principals, agents, contractors, trustees, or otherwise.

(h) To do all and every thing incident, usual, necessary, suitable, convenient or proper for the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or incidental to the powers herein named, or which shall at any time appear conducive or expedient for the protection or benefit of the corporation either as holder of or interested in any property, or otherwise; with all the powers now or hereafter conferred by the laws of the said Province upon corporations under the said Act and the Acts in amendment thereof.

3. The office or principal place of business is to be at Chipman, in the Parish of Chipman, in the County of Queen's, in the said Province of New Brunswick.

4. The amount of the capital stock of the Company is to be Twenty thousand dollars, divided into two hundred shares of One hundred dollars each.
