

PUBLIC NOTICE is hereby given, that the applicants hereinafter named will, at the expiration of two weeks from the publication of this notice, apply by Petition to His Honour the Lieutenant-Governor of the Province of New Brunswick in-Council, for a grant of a charter of incorporation under the Great Seal of the said Province of New Brunswick, under and in accordance with the provisions of "The New Brunswick Joint Stock Companies Act," and amending Acts, incorporating and constituting the applicants, and such other persons as may hereafter become shareholders in the proposed company, a body corporate and politic under the name and for the purposes hereinafter mentioned.

(1) The proposed corporate name of the Company is "**Furnishers, Limited.**"

(2) The objects and purposes for which the incorporation of the Company is sought are:

PURPOSES.

(a) To act as agent for, buy, acquire, take over, import, export, manufacture, operate, own, repair, hold, deal in, use, publish, print, lithograph, do stereotyping, engraving, wood-cutting and book-binding, lease, sell and dispose of for cash or on the hire, conditional sale, or instalment plan (wholesale and retail), Bibles, albums, pictures, magazines, printed and blank books of every nature, kind and description; to act as agent for, import, own, export, buy, acquire, take over, manufacture, repair, hold, deal in, use, lease, sell and dispose of for cash or on the hire, lease, conditional sale or instalment plan (wholesale and retail), clocks, watches, ornaments, furniture, wringers and household goods of every kind and description. To act as agent for, import, own, export, buy, acquire, take over, manufacture, hold, deal in, use, lease, sell and dispose of for cash or on the hire, lease, conditional sale or instalment plan (wholesale and retail) all kinds of stock-in-trade, personal property, goods and chattels, patents, patent rights, and patented articles, wares and merchandise of every nature, kind and description that may by the said Company or its Directors be deemed necessary, expedient and advisable; to buy, own, sell and dispose of chattel leases, hire leases, conditional sale and instalment agreements, debts, evidences of debt and choses in action of every nature, kind and description, and generally to do all things necessary therefor or incident thereto.

(b) To take securities from agents or persons in the employment of or dealing with the said Company for the proper performing or carrying out of contracts made with the said Company, and generally to do all things necessary therefor or incident thereto.

(c) To take security or securities from any person or persons, corporation or corporations, to whom the said company has sold goods, wares, merchandise, chattels or personal property of whatever nature, kind and description, to secure the purchase price or prices of the same, or any part thereof, by hypothecation, mortgage or mortgages, pledge or pledges on goods, chattels, wares and merchandise and personal property of whatever description, including life insurance policies, and by means of bonds or securities of any kind from any person or persons, corporation or corporations whatsoever.

(d) To buy, acquire, take over, hold, own, deal in, sell and dispose of shares, stocks, debentures or securities of any other Company, subject to the provisions of the above mentioned Act, chattel leases, hire leases, conditional sale and instalment agreements, debts and evidences of debt, and choses in action of every nature, kind and description, and generally to do all things necessary therefor and incident thereto.

(e) To buy, or otherwise acquire, own and undertake and carry on all or any part of the business, good will, property or liabilities of any person or persons, corporation or corporations carrying on any business which the said Company is authorized to carry on, or possessed of property suitable for the purposes of the said Company, when duly authorized so to do by a by-law confirmed at a general meeting of the said company, and generally to do all things necessary therefor and incident thereto.

(f) To enter into any agreement for sharing profits, union of interests, amalgamating or co-operating with any person or persons, company or companies carrying or about to be carrying on any business or transaction capable of being conducted so as to benefit the said company, when duly authorized so to do by a by-law confirmed at a general meeting of the said Company, and generally to do all things necessary therefor or incident thereto.

(g) To act as agent for any person or persons, corporation or corporations, and generally to do all things necessary therefor or incident thereto.

(h) To act as agent for, work at, do business as, can, cure, prepare, compound, operate, own, import, export, manufacture, repair, buy, sell or deal in (wholesale or retail) dispose of for cash or on the hire lease, conditional sale, or instalment plan, agricultural implements of every nature, kind and description, automobiles, cycles, bicycles, typewriters, tricycles, motors, engines, carriages and conveyances of every nature, kind and description, confectionery, sugar, syrups, biscuits, bread-stuffs, cakes, boats and vessels, boots and shoes, leggings, laces, belts, trunks, bags and leather goods of all kinds, brooms, brushes, whisks and domestic wares of all kinds, canned, preserved, pickled and cured fruits, vegetables, grains, meats, fish, fowl and game and extracts, jams, marmalade, essences, sauces, relishes, jellies, aerated or evaporated fruits, cider and cider vinegar, carpets, rugs, yarns, wool, cotton and jute, all kinds of cast-iron and brass work, all kinds of tools and implements and vehicles, druggists' specialties, medical and pharmaceutical preparations and toilet requisites, tobacco, tobacco pipes, cigars, cigarettes and other products of tobacco, all kinds of ready-to-wear or made-to-order clothing, garments, wearing apparel, furnishings, fancy goods and kindred articles, coffee, spice and other condiments for general use, shirts, collars, cuffs, and all kinds of goods, wares and merchandise, provisions, material and goods of every description, corsets, corset waists, infant's bands, corset steels, corset clasps, dress steels, dress shields, hose supporters, bustles, laces, lace, lace trimmings, corsets and other boxes and cartons and dry goods and small goods in general, butter, cheese, milk and dairy products, general dry goods, all kinds of goods and merchandise generally, drapers, haberdashers, milliners, dress makers, tailors, furriers, lacemen, clothiers, hosiers, glovers, and general outfitters, electrical apparatus, and appliances and machinery, instruments

of all kinds, fences, posts, and goods of all kinds, trees, plants, shrubs, seeds and flowers, flour, oatmeal and all kinds of grain, heating furnaces and their attachments, stoves and ranges of every nature, kind and description, furniture, boxes, metal, metal work, plated ware, castings, dies and fittings, furnishings and supplies for offices, vaults, schools, churches, halls, theatres and other public and private buildings, all kinds of raw materials, all kinds of materials used for painting, glazing and decorating houses and buildings and signs, stained and ornamental glass, mitts, gauntlets, hats, caps, robes, fish, meats and groceries of all kinds, goods, wares, merchandise of all kinds, hardware and kindred goods, ice and ice dealers, supplies, iron, steel or metal, precious stones, jewellery, bullion, clocks, watches and other articles similar thereto, clockmakers' and watchmakers' supplies, tools, machinery and equipment of all kinds, paper, embossers, engravers, paper makers, cloaks, dresses, and all kinds and descriptions of garments and clothing, all kinds of physicians' supplies, surgical appliances, dental supplies, drugs, proprietary medicines and druggists' supplies and sundries, all beverages, foods and compositions and compounds, carbonated, mineral, distilled and table waters and non-alcoholic beverages, mineral wool, bricks and all kinds of wood, silica cement, neckwear, furnishings, small wares of every description, newspapers, periodicals, publications, paper bags, petroleum, pianos, all kinds of musical instruments, ornamental and other glass, photo engraving, pulp wood, lumber, timber, salt, harness, saddlery, whips, blankets, bells, leather bags, fly nets, sewer pipes, terra-cotta and all products of clay, sand or cement, cotton, linen, silk and other textiles, fabrics, overshoes and rubbers, essential oils, perfumes, pomades, glycerine, lard and oils, and all kinds of caustic, carbonate and bi-carbonate alkalies, gas ranges, and all kinds of every kind, skins, tea, coffee, tents, sails, flags, awnings, rope, cordage, twine, oakum, hemp, jute, flax, manilla, sisal, paper and other fibres, carpets, waggon, sleighs, farm and railroad carts, carriages and vehicles of all descriptions, and all articles and things of every nature, kind and description used in the construction of or in connection with all and singular the same or any of them, and generally to do all things necessary or incident thereto.

(i) To carry on the business of merchants, manufacturers and dealers (wholesale and retail) in all kinds of metals, and all materials and supplies relating thereto; to conduct the work and business of a foundry, machine-shop, factory, engine, structural metal, boat and bridge building establishment, to manufacture, construct, repair, buy, sell, let, hire, exchange, trade and deal in articles, tools, machines, machine tools, constructions, erections, conveniences and vessels, including locomotive engines, stationary engines, and all other engines, motors, electrical apparatus, air compressors, mining and pumping machinery, boilers, machinery of all kinds, railway cars, trucks, carriages, rolling stock for railways, yachts, boats, barges, tugs and all other vessels and parts of the same, and all articles composed or manufactured in whole or in part of iron, steel or other metal or wood, paper or other material, or combination thereof.

(j) To manufacture, buy, and sell, and to otherwise deal with Portland cement, marl, Kriselguhr clay, putty, whitening, bricks, lime, paints, fertilizers, deodorizers, drain and other tiles and stone, and gravel, and artificial stone and its products, and to manufacture and deal in all compositions into which any of the said articles and materials can be converted or used, and for the said purposes to construct and operate on the property of the company, or on property to be acquired for the purpose, tramways to railroads, and to navigable waters, and to the various marl beds, clay lands and cement rock deposits and other properties of the company, subject to the consent of Municipalities, and of owners of property interested and of all existing laws, and to build pipe lines from the said marl beds to the company's works.

(k) To purchase, lease or otherwise acquire, water-powers and water privileges for the purpose of generating power or electricity with which to carry on the company's operations. To purchase, own, lease, charter and operate vessels for the purpose of conveying cement and other materials and goods in connection with the company's works, to build docks, wharves and works where it may be found necessary to carry on the company's business, and to build store houses and elevators at any point where it may be found necessary to carry on the company's business.

(l) To manufacture and deal in iron, steel and all other metals.

(m) To conduct a general plumbing, heating and sheet metal business, and to manufacture, sell, import, export, and deal in plumbing, heating, engineering, electrical, gas, hardware, metal and waterwork supplies.

(n) To carry on business as a timber merchant, saw mill proprietor and timber grower, and to sell, grow, prepare for market, manipulate, export, import, and deal in wood and timber of all kinds, and to manufacture and deal in articles of all kinds used in the manufacture of which timber or wood is used, and for the said purposes.

(o) To carry on the business of transferring from place to place goods, wares, merchandise and persons by means of carts, waggon, carriages, omnibusses and other vehicles, and any business incidental thereto; to carry on the business of warehousemen, and keepers of warehouses, yards and other places for the storage of goods, wares and merchandise, and any business incidental thereto.

(p) To pay out of the funds of the said company all expenses of or incidental to the formation, registration and advertising of the said company, remunerate any person or persons, company or companies, for service rendered in placing of the shares of the capital of the said company, or in or about the formation of the said company, or in the conduct of its business when duly authorized so to do by a by-law confirmed at a general meeting of the said company.

(q) To buy, own, or otherwise acquire, possess, build, erect, hold and keep, improve, manage, lease, mortgage, hypothecate, alienate, sell and convey all real and personal estate and property requisite for carrying on all undertakings of the said Company, including mills, factories, workshops, warehouses, storehouses, dwellings, barns and all other buildings, structures and erections by the said company or its directors deemed necessary, expedient and advisable in connection with the said undertakings to be bought or built, and generally to do all things necessary therefor or incident thereto.
