

NOTICE OF GRANTING LETTERS PATENT.

PUBLIC NOTICE is hereby given, that under Chapter Eighty Five of the Consolidated Statutes of New Brunswick, 1903, and amending acts, Letters Patent have been issued under the Great Seal of the said Province, bearing date the Eighth day of February, A. To engage generally in the fish business in the waters and along the coast of the Province of New Brunswick.

To purchase, lease, or otherwise acquire, own and deal in real estate, buildings, plant and machinery, raw material and other necessary products and materials to be used in the packing and preserving of fish of all kinds, including factories, wharves, fish stands, boats, moorings and all and every equipment and appliance necessary for the purpose of carrying on a general fish business.

To purchase and acquire the stock-in-trade, real and personal property, franchises, patents, patent rights, licenses, effects, good will and assets of any person or persons or incorporated company now or hereafter carrying on any business similar to that proposed to be carried on by the Company or to take security thereon, and to continue the same when so acquired and to sell and dispose of the same and any or every part thereof.

To buy, sell and generally deal in all kinds of merchandise and to do all and every matter and thing necessary for and incidental to the above mentioned purposes and objects by the name of "Port Elgin Fish Company, Limited," with a total capital stock of Twenty Four thousand dollars divided into Twenty Four hundred shares of Ten dollars each, and with the head office of the said Company at Seal Cove, in the Parish of Grand Manan, in the County of Charlotte.
