

NOTICE is hereby given, that the persons hereinafter named will apply to His Honour the Lieutenant-Governor-in-Council, for the grant of a Charter of Incorporation by Letters Patent, under the Great Seal of the Province of New Brunswick, in accordance with the provisions of "The New Brunswick Joint Stock Companies' Act," and Acts in amendment thereof, incorporating the applicants and such other persons as may hereafter become shareholders in the proposed Company, a body corporate and politic under the name and for the purposes hereinafter mentioned.

1. The proposed corporate name of the Company is "The New Brunswick Estates Company, Limited."

2. The objects for which Incorporation is sought are:—

(a) To purchase, sell, lease, acquire options on, contract to buy or sell, and generally deal in farm lands, fruit lands, timber lands, houses, cottages, shops, offices, warehouses, hotels, and other buildings and real estate of all kinds in this Province and elsewhere; to improve such lands by cultivation, planting of trees, erection, and maintaining of buildings, cottages, railway sidings, railway spurs to and on such land and premises, and make any other improvements, with full powers to lease, mortgage, sell, and otherwise deal in the same or any part thereof; to act as agents of any person or persons owning or interested in real estate of any kind, or in leasehold property or both; to borrow money upon the credit of the Company; to mortgage, pledge and hypothecate the undertaking of the Company, or any part thereof, and any real or personal property belonging to the said Company, and to sell, exchange, convey and turn to account or otherwise deal with and dispose of the same; to issue bonds, debentures or other securities for the lawful purposes of the Company, and to pledge or sell the same for such sums and prices as may be deemed expedient or be necessary, and to hypothecate any or all such bonds, debentures or other securities.

(b) To conduct and carry on said business of dealing in real estate, and to buy, sell and deal in any and all grains, seeds, fruits, and also in all dairy, orchard, nursery and other farm products, lumber and lumber products, and to manufacture and sell all useful products therefrom, and to purchase or erect and operate all necessary mills, elevators, warehouses and machinery, and to act as dealers in the purchase and sale of seeds, grains, fruits, and of all dairy, orchard, nursery and other farm products, and to act as agents for remuneration or otherwise for all parties in the purchase and sale of the same.

(c) To carry on in all its branches the business of, farming, dairying, stock raising, and also general orchard and nursery business, with full power to purchase, lease, take over or otherwise acquire other farming, orchard and nursery properties, or any one of them.

(d) To construct, carry out, maintain, improve, manage, work, control and superintend any roads, ways, pipe lines, tramways, railway sidings, terminals on land owned or controlled by the Company, bridges, reservoirs, water-courses, water powers, water rights, electrical works, factories, warehouses, shops and houses and other conveniences which may seem directly or indirectly conducive to or convenient for any of the objects of the Company.

(e) To furnish and sell electricity for power, heat and lighting purposes, and all appliances incidental or necessary thereto, provided, however, that any distribution or transmission of electricity beyond the lands of the Company shall be subject to municipal and local regulation in that behalf.

(f) To acquire any other business of a similar nature or character which the Company is authorized to carry on or do, and the good will thereof, on such terms as to the payment for the same by the issue of stock or bonds of the Company, or otherwise as may be agreed upon, and to acquire or undertake the whole or any part of the business, properties and liabilities of any company having objects altogether or in part similar to those of the Company hereby incorporated.

(g) To carry on any other business incident to the said objects of the Company or capable of being conveniently carried on in connection with any of the business aforesaid.

(h) To publish and distribute literature descriptive of the Company's properties, and take such steps to bring in immigrants and settlers to purchase its property or properties as may seem desirable, as well as open agencies, employ agents and advertise its business.

(i) To draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, bills of lading, warrants, or other negotiable and transferable instruments.

(j) To do all such other things as are incidental or conducive to the attainment of the above objects and to do all or any of the above things as principals, agents, contractors, trustees or otherwise and by or through trustees, agents or otherwise and either alone or in conjunction with others.

(k) To issue shares of stock, as fully paid up and non-assessable, to the promoters and directors of the Company in payment for organization and other expenses, and for services of the Directors and other persons for the Company.

3. The office or chief place of business of the Company is to be at the Town of Woodstock, in the County of Carleton in the Province of New Brunswick.

4. The amount of the Capital Stock of the Company is to be Fifty thousand dollars, divided into Five hundred shares of One hundred dollars each.

NOTICE is hereby given, that the persons hereinafter named will apply to His Honour the Lieutenant-Governor for a Grant of Letters Patent of Incorporation under The New Brunswick Joint Stock Companies' Act, and amendments thereto.

(1) The proposed Corporate name of the Company is "Lower Restigouche Fishing Club."

(2) The objects for which the incorporation is sought are as follows:—

(a) To promote the health and recreation of its members by the pursuit of fishing and hunting.

(b) To purchase, lease or otherwise acquire personal property and real estate and thereon to erect houses and other buildings required from time to time for the accommodation of its members, agents, officers and servants and to furnish, equip and manage the same.

(c) To acquire and hold the right to be exercised by its members to fish in any river, lake or stream and to sublet the right it may have to fish in said rivers, lakes and streams and to grant permission to such persons as it may see fit to fish in said waters.
