APPLICATION FOR LETTERS PATENT

LITTLE RIVER SILVER BLACK FOX COMPANY, LIMITED, IN THE MATTER OF "THE NEW BRUNSWICK JOINT STOCK COMPANIES' ACT."

NOTICE is hereby given that the persons hereinafter named a will apply to the Lieutenant-Governor-in-Council, for a grant by Letters Patent, under the Great Seal of the Province of New Brunswick, of a Charter constituting the persons hereinafter named and others who may become share-holders in the Company, proposed to be hereby created, a body corporate, and politic, for the purposes and objects hereinafter named, that is to say:

1. The proposed corporate name of the Company is "Little River Silver Black Fox Company, Limited."

2. The objects for which the incorporation of the said proposed Company is sought are as follows:

(a) To engage in a general ranching business for the breeding and rearing of foxes and other fur bearing animals in captivity.

(b) To buy, sell, exchange, acquire and otherwise deal in foxes and other fur bearing animals.

(c) To buy, sell, acquire and deal in raw ani manufactured furs, skins, pelts and hides manufactured, and to tan, cure and preserve skins, pelts and hides of all kinds, to transact any business relating thereto, and to carry on the trade and business of buying, selling and dealing in furs and the breeding and raising of fur bearing animals.

(d) To make, execute and enter into contracts and agreements with any person or persons or with any Com-
