

NOTICE OF GRANTING LETTERS PATENT.

PUBLIC NOTICE is hereby given, that under Chapter Eighty-five of the Consolidated Statutes of New Brunswick, 1903, and amending Acts, Letters Patent have been issued under the Great Seal of the said Province, bearing date the twenty-eighth day of May, A. D. 1913, incorporating: Rufus L. Hicks, of Dalhousie Junction, in the County of Restigouche, and Province of New Brunswick, Farmer; William S. Smith, of the Town of Dalhousie, in said County and Province, Gentleman; Allan Mc C. Hicks, of Dalhousie Junction aforesaid, Mill Owner; Lillian J. Hicks, of Dalhousie Junction aforesaid, wife of Allan Mc C. Hicks, and A. Ernest G. McKenzie, of the Town of Campbellton, in said County and Province, Barrister, for the following purposes, namely:

To build, erect, purchase, take by lease or otherwise acquire, maintain, operate, sell or otherwise dispose of saw mills, shingle mills, lath mills, box mills, and other mills for manufacturing all products of wood in the Province of New Brunswick.

To purchase, take by lease, or buy from the Crown, or from any person or persons, company or companies, and take by assignment or transfer of leases or licenses granted by the Crown, or by any person or persons, company or companies, or otherwise acquire timber lands, timber limits and right to cut timber in the Province of New Brunswick and elsewhere, and to sell or otherwise dispose of the same.

To lumber, cut, haul, get out, to purchase or otherwise procure all kinds of timber and trees, whether growing on or severed from the soil, including saw logs, pulpwood, shingle logs, shingle wood, lath wood, railway ties and other kinds of wood, and to sell, manufacture or otherwise dispose of the same.

To manufacture, buy, sell or otherwise deal or trade in deals, planks, boards, shingles, laths and other kinds of manufactured lumber and other goods and articles of all kinds in the manufacture of which timber or wood is used.

To purchase, construct, take by lease or otherwise acquire, operate or charter or navigate steam or sailing vessels, boats or row boats of every kind and nature whatsoever, and to sell, dispose of or otherwise deal in the same.

To repair, renew or rebuild steam or sailing vessels of every kind and description whatsoever.

To conduct and carry on a general merchandise business, wholesale or retail, or both, and the buying and selling of goods, wares and merchandise of every kind and description.

To store, warehouse, carry and transport goods, wares and merchandise of any kind whatsoever, for hire or reward, and to carry and transport passengers by land or water for hire or reward.

To construct, take by lease or otherwise acquire, maintain and for hire or reward operate wharves, docks, dry docks, graving docks and repairing docks in the Province of New Brunswick, and to sell or otherwise dispose of the same.

To purchase, take by lease or otherwise acquire, water rights, water power, electrical power or other power, and to sell or otherwise dispose of the same.

For all or any of the purposes or objects aforesaid: To purchase, take by lease or otherwise acquire lands, tenements and hereditaments in the Province of New Brunswick. To construct, make or manufacture, purchase, take by lease or otherwise acquire and to maintain all materials, articles, tools, engines, boilers, tackle, apparel, furniture, machinery of all kinds, cranes, hoisting gear and other appliances and facilities for loading and discharging vessels, tramways, railway sidings, piers, booms, machine shops, warehouses and buildings for the storage of goods, wares and merchandise.

To sell or otherwise dispose of the lands, tenements, hereditaments, water, electrical or other power, materials, articles, tools, machinery, engines, boilers, tackle, apparel, furniture, piers, booms, machine shops, warehouses and buildings and cranes and other appliances and facilities mentioned in the last clause above.

To lease, sell, mortgage, pledge or otherwise dispose of or encumber the undertakings of the Company, or any part thereof and any or all of the real and personal property of the Company for such consideration and in such manner, and upon such terms as to the Company may seem desirable.

To do all things and everything necessary, proper, suitable or convenient for the accomplishment of any of the purposes for the attainment of any one or more of the objects herein enumerated or incidental to the powers herein specified or which shall at any time appear necessary or expedient to be done for the protection or benefit of the Company either as owner of or interested in any property or otherwise to the same extent or as fully as natural persons might or could do; by the name of "Restigouche Lumber Company, Limited," with a total capital stock of seventy-five thousand dollars divided into seven hundred and fifty shares of one hundred dollars each, and with the head office at Dalhousie Junction in the said Province.

BRIDGE NOTICE.

SEALED TENDERS marked "Tender for Grand Falls bridge metal superstructure" will be received at the Department of Public Works, Fredericton, until Monday, 14th day of July, 1913, at noon, for constructing the metal superstructure of the Grand Falls Bridge, over the St. John River, between the Parishes of Grand Falls and Drummond, Victoria Co., N. B., consisting of the following: One through fixed riveted steel truss span of 140 feet, centre to centre of end bearings; One through fixed riveted steel truss span of 230 feet, centre to centre of end bearings, according to plans and specifications to be seen at the Public Works Department, Fredericton, N. B.

Each tender must be accompanied by a certified bank cheque or cash for an amount equal to five per cent. of a grand total amount, made up as follows: \$60,000 lbs. of metal superstructure at a tendered rate per lb.; plus the tendered lump sum for the roadway floor construction, embracing reinforced concrete sidewalk, reinforced concrete base for wagon roadway with its creosoted wood block wearing surface, and all concrete side curbs appertaining to such floor system. Such certified bank cheque or cash will be returned to the parties whose tenders are not accepted, but with the party to whom the contract is awarded, it shall be retained until the final completion of the contract and its acceptance by the Department.
