

tion or promotion of the Company or in the conduct of its business.

(k) To distribute in specie or otherwise as may be resolved any assets of the Company among its stockholders, and particularly the shares, bonds, debentures or other securities of any other company that may take over the whole or any part of the assets or liabilities of the Company.
