

bedding, flour and feed, hay and straw, farm produce, fancy goods and hardware.

(i) To carry on the business of warehousemen, including the operation of refrigerators, cold storage warehouses and plant.

(j) To carry on the business of wholesale and retail grocers of provisions, canned goods, confectionery, jellies, preserved fruit, fruit, teas, coffee, spices, pickles, dried fruit, flour, tobaccos, molasses, pork, meats and fish, and to deal in all products and goods as required in a wholesale and retail grocery business.
