bag any of the vegetables mentioned in sub-section 2 of section 337 of this Act, shall, in case any bag of such vegetables sold or offered for sale by him does not contain at least the number of Dominion standard pounds required by the said sub-section, be liable, on summary conviction, to a penalty not exceeding twenty-five dollars for a first offence, and for each subsequent offence to a penalty not exceeding fifty dollars."

21. This Act shall come into force on the first day of January, one thousand nine hundred and fifteen.
