

## APPLICATION FOR LETTERS PATENT

## THE RICHMOND FOX AND FUR COMPANY, LIMITED.

NOTICE is hereby given, that application will be made by the applicants hereinafter named to His Honor the Lieutenant-Governor-in-Council for a grant of Letters of Incorporation under the Great Seal of the Province of New Brunswick, under the provisions of the New Brunswick Joint Stock Companies' Act and amending Acts, incorporating and constituting the applicants and such other persons as may become shareholders in the proposed company a body corporate and politic under the name and for the purposes hereinafter mentioned.

1. The proposed corporate name of the company is "The Richmond Fox and Fur Company, Limited."

2. The following are the objects for which incorporation is sought:

(a) To engage in a general ranching business for the breeding and rearing of foxes and other fur-bearing animals in captivity for market value and commercial purposes.

(b) To buy, sell, exchange, import and export and deal in foxes and other fur-bearing animals, alive and captive, for breeding and rearing purposes.

(c) To make, execute and enter into contracts and agreements with any persons or companies having objects similar in whole or in part to those of this company, for the housing, feeding, keeping, rearing or breeding of any, such captive fur-bearing animals.

(d) To carry on a trade and business in raw and manufactured furs; to buy and sell skins, pelts and hides, both manufactured and unmanufactured, and to transact any business relating thereto.

(e) To acquire by purchase, lease or otherwise, such real estate as may be required for the business of the said company, and to sell, encumber or mortgage the same for the purposes thereof, or as may be.

(f) To erect upon such lands of the Company all houses, barns, pens and other buildings, walls, yards, fences and enclosures necessary, requisite or incidental to the purposes of such ranching business.

(g) To acquire the good will, plant, rights and property of any kind, and to acquire and undertake the whole or any part of the assets and liabilities of any person, firm, association or corporation having powers similar to those of this company, and to pay for the same in cash, stock or bonds of this company, or otherwise.

(h) To amalgamate with any other company having powers similar to those of this company.

(i) To acquire by purchase, subscription or otherwise, and to hold, sell or otherwise dispose of shares, stocks, bonds or obligations of any company having powers similar in whole or in part to those of the company, and to vote thereon as owners thereof.

(j) To acquire and dispose of patent rights, trade marks and trade processes, secret or otherwise.

(k) To do any and all things set forth as objects, purposes, powers or otherwise to the same extent and as fully as natural persons might or could do, and in any part of the world, as principals, agents, contractors, trustees, assignees or otherwise.

3. The head office or chief place of business of the company is to be at the Town of Woodstock, in the County of Carleton, and Province of New Brunswick.

4. The amount of the capital stock of the said Company is to be twenty thousand dollars, divided into two thousand shares of ten dollars each.

NOTICE is hereby given, that application will be made by the Town of Bathurst and by Bathurst Lumber Company, Limited, to the Legislative Assembly of New Brunswick at its next session for the passing of an Act—

1. To close that part of Old Miramichi Road, in the Town of Bathurst, extending northward from its junction with Caraque Highway to Bathurst Harbour; also the right of way from Caraque Highway to Caraque Railway Station and Machine Shop and other rights of way and landings in Town of Bathurst east of Nepisquit River, and to vest the soil right thereof in Bathurst Lumber Company, Limited.

2. To enable Town of Bathurst to close part of Highway leading to Nepisquit Bridge northwest of Nepisquit River, in Town of Bathurst, and to open a new highway in lieu thereof to the northward thereof, and to vest the soil right in the portion so closed in Bathurst Lumber Company, Limited.

3. To enable owners of "Y" branch of Caraque Highway to convey part thereof east of Caraque Highway, freed from all liens and encumbrances, to Bathurst Lumber Company, Limited, and to remove its station and railway buildings to another position, and that all liens and encumbrances on the portion so conveyed shall attach to the new station, buildings and branch, when built and acquired.

4. To enable Bathurst Lumber Company, Limited, to develop water powers on Nepisquit River, and establish and maintain electrical transmission line therefrom to Bathurst, and to lay a pipe line or lines from head of tide water of Nepisquit and Middle Rivers, and convey water from said rivers therein to its proposed pulp and paper mills, and for all of above purposes to expropriate all necessary lands and rights of way.

5. To fix the valuation for taxation purposes on properties of Bathurst Lumber Company, Limited, and pulp and paper mills to be erected thereon, for a period not exceeding thirty years.

6. To prohibit issue of licenses for sale of liquor in that part of Town of Bathurst east of Nepisquit River, and in Parish of Bathurst within one mile of eastern end of Nepisquit Bridge.

7. To enable any new company to be incorporated for purpose of building and operating pulp and paper mills at Bathurst upon or in connection with the properties of Bathurst Lumber Company, Limited, to have and exercise all the rights given, when incorporated, in same manner as same could be enjoyed by that Company under the proposed Act.
