If the works of any company are to be declared to be for the general advantage of Canada, the same shall be specifically mentioned in the notice, and a copy of such notice shall be sent by registered letter to the clerk of each county or municipality which may be specially affected by such works, and also to the Secretary of the Province in which such works are or may be located; and proof of such service of notice shall be established cated; and proof of such service of notice shall be established by statutory declaration.

In addition to the notice in the Canada Gazette aforesaid, a similar notice shall be published in some leading newspaper, as follows
