GOVERNMENT NOTICES

NOTICE is hereby given that the following regulation passed by the Executive Council on January 6th, 1904, and duly approved, is in full force:

"It shall be unlawful for any person or persons to dig claims on the foreshores, being the land between high and low water mark, of the County of Charlotte, in the Province of New Brunswick, and any person digging claims upon such foreshores without a license to be issued by the Surveyor General, or without the authority of the licensee under any such license, shall be liable to a penalty of not more than One hundred dollars and not less than Ten dollars, which penalty may be recovered under the provisions of the Summary Convictions Act by any person prosecuting for the same."
