contractor with the said Company (other than the Quebec and Saint John Construction Company), shall have failed to complete his contract with his employing contractor or sub-contractor, any claim or counter claim for damages which the latter may have, shall not be adjudicated upon by the person so appointed, but the person having such claim or counterclaim may proceed at law in the ordinary way for the recovery thereof and the same shall not be offset or counter-claimed for in respect to the moneys so retained or deposited with the Provincial Secretary-Treasurer, it being the intention of this Act that so far as possible such moneys shall be distributed among all classes of claimants in proportion to the wages earned, labour performed and materials and supplies provided by each class so far as the amount to be distributed to the next superior claimant may permit the same to be done, and when the amount so to be distributed is not sufficient to pay such claims in full, it shall be apportioned pro rata among the claimants and the balance shall be a claim against the Company. The Lieutenant-Governor-in-Council may, at the request of any contractor, by Order-in-Council, require the Company to submit any matter or dispute between it and any contractor to arbitration under the Arbitration Act, 1909, and if the Company fail to make such submission within ten days after it shall receive notice of such Order-in-Council, the Lieutenant-Governor-in-Council may appoint an arbitrator for the Company, and such dispute shall be arbitrated under the said Act and the award therein shall be of the same force and effect as if the Company had made such submission and before becoming entitled to any guarantee of bonds, or payment under this Act, the Company shall furnish to the Lieutenant-Gov-ernor-in-Council satisfactory evidence that all just claims against contractors or sub-contractors for materials, wages and supplies in connection with work hereafter to be done on said railway shall have been paid and satisfied. The provisions of this section shall not apply to the Quebec and Saint John Construction Company." 4 ins
