WHEREAS, the Legislative Assembly of this Province stands prorogued to Thursday, the twenty-sixth day of July inst., I have thought fit further to prorogue the said Legislative Assembly, and the same is hereby prorogued accordingly, to Thursday, the sixth day of September next.

Given under my hand and seal at Fredericton, the twentyfifth day of July, in the year of our Lord one thousand nine hundred and seventeen, and in the eighth year of His Majesty's reign.
