Either by itself or in conjunction with some other company or companies, person or persons, to institute, operate and run a theatre and theatres in the City of St. John and elsewhere in the Province of New Brunswick and in connection therewith to give exhibitions of motion pictures and musical, literary, operatic, dramatic vaudeville, and other entertainments and amusements of a similar nature and to charge therefor such admission and other fee as to the company shall deem reasonable.

To buy, sell, lease, rent and otherwise deal in films, scenery, machinery or other things ordinarily used or which can reasonably be used in a theatre or in the giving of such exhibitions and entertainments.

To construct, purchase or otherwise acquire, hold, maintain and operate works for the generation and distribution of electrical energy and the transformation thereof into light, heat and power for the use, uses and purposes of the Company and to sell and dispose of for consideration and reward, such light, heat and power to the occupants of the buildings of that portion of the city of Saint John which lies between King Square and Union street and between Charlotte street and Sydney street.

To construct, purchase, lease or otherwise acquire, hold, maintain and operate all buildings, erections and plant which the Company may deem necessary or convenient for carrying out the aforesaid purposes of the Company.
