ORDERS OF THE BOARD OF EDUCATION.

STUDENT-TEACHERS shall be required hereafter, at the time of their admission to the Normal School, to give a bond with an approval surety in the sum of one hundred dollars (\$100) to His Majesty the King, that they will give three years' service in the work of teaching in the public schools in the Province, before engaging in that occupation elsewhere.

Beginning with the next school year, and continuing until the end of the war, the age of admission to the Provincial Normal School shall be sixteen (16) years.
