JUDICATURE ACT, 1909.

RULES OF COURT.

ORDER LIX is hereby repealed and the following substituted in lieu thereof: ORDER LIX.

Appeals from Divorce, County and Probate Courts.

1. On an appeal from the Court of Divorce and Matrimonial Causes it shall be the duty of the appellant to file with the Registrar of this Court certified copies of the ibbel and other pleadings and decrees, and to cause to be filed the transcript of the stenographer's notes of the evidence taken in the Court of Divorce and Matrimonial Causes on file in that Court, or, failing that, a proved copy of the same.

2. On an appeal from the Court of Divorce and Mitrimonial Causes, the Court of Appeal may grant to a wife appellant costs or suit money payable by the respondent to enable her to carry on the appeal.
