UNDER and by virtue of Section 79 of Part 1 and Section 85 of art 2 of the Acts of the Legislative Assembly, 5 George V., 1913, Chapter 37, entitled "An Act to provide for Compensation to Workmen for Injuries sustained and Industrial Diseases contracted in the course of their employment," and by an Order-in-Council thereunder made, and pursuant to the power and authority thereby in me vested, I do order and declare that all the remaining provisions of Part 1 of said Act not referred to and proclaimed by the Proclamation made under the provisions of the said Act, dated the seventeenth day of September, A.
