NEW TIMBER REGULATIONS-IN EFFECT 1st AUGUST, 1918.

1. The provisions of Chapter 11, 3 George V., 1913, are now applicable to all Timber Licenses now in force, or hereafter applied for, except to Licensees who elect to renew their existing licenses, which are in effect, if the Licensee so desires, until 1st August, 1918, when they become utterly null and void. All Licenses, whether LCW or renewed, are subject to the provisions of these regulations.

2. Saw-mill Licenses extend for a period of twenty years from 1st August, 1913, with a renewal of ten years, as specified in above Act, upon continued compliance with the said Act, with the Order-in-Council dated 10th July, 1913,

providing for the payment of the bonus as set forth in said Act, and these Regulations. 3. Pulp and Paper Licenses extend for a term of thirty years, and subject to an extension of twenty years, upon compliance with above Act; the Order-in-Council of 10th July, 1913, providing for the payment of bonus as set forth in said Act and these Regulations.
