All such notices, whether inserted in The Canada Gazette or in a newspaper, shall be published at least once a week for a period of five consecutive weeks; and when published in the provinces of Quebec and Manitoba shall be in both the English and French languages; and marked copies of each issue of all newspapers containing any such notice shall be sent to the Clerk of the Senate, epdorsed 'Private Bill Notice,' or statutory declaration as to the publication may be sent in lieu
